AN ORDINANCE AMENDING CHAPTER 500 OF THE CITY OF PEVELY MUNICIPAL CODE PERTAINING TO SECTION 500.090 QUALIFICATIONS OF BUILDING OFFICIAL

WHEREAS, the Mayor and Board of Aldermen of the City of Pevely, Missouri wish to amend the qualifications of the Building Official to a more desirable level of experience; and

WHEREAS, the most appropriate way to amend the qualifications of the Building Official is to repeal and replace in its entirety Section 500.090 of the Pevely Municipal Code which pertains to the qualifications of the Building Official.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PEVELY, MISSOURI, AS FOLLOWS:

Section 1. Section 500.090 of the City of Pevely, Missouri Municipal Code is hereby repealed in its entirety and replaced by the following language:

Section 500.090 Qualifications of Building Official

To be eligible for appointment, the appointee shall have previous building experience and shall be generally informed on good engineering and building practices in respect to the design and construction of buildings, the accepted requirements for means of ingress and egress, and the installation of other service equipment necessary for the health, safety, and general welfare of the occupants and the public. The Mayor and Board of Aldermen shall have the sole discretion to determine the appointee's eligibility.

- Section 2. The Mayor and the officers, agents and employees of the City are hereby authorized and directed to take such further action and execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the terms of the proposed Contract.
- Section 3. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is, for any reason, held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinctive, and independent provision and such holding shall not affect the validity of the remaining portions hereof.
- Section 4. This Ordinance shall be in full force and effect from and after the date of its passage and approval.

AN ORDINANCE OF THE CITY OF PEVELY AMENDING SECTION 200.060 OF THE CODE OF ORDINANCES OF THE CITY OF PEVELY REGARDING THE COMPOSITION OF THE POLICE PERSONNEL BOARD TO PROVIDE FOR TWO ALTERNATE MEMBERS

WHEREAS, the City of Pevely, Missouri (the "City") wishes to amend §200.060 of the Code of Ordinances of The City Of Pevely, regarding the composition of the Police Personnel Board to provide for two alternate members; and,

WHEREAS, the Board of Aldermen of the City of Pevely believe such a change will afford the Police Personnel Board the ability to effectively carry out its mandate and would be in the best interest of the citizens of the City of Pevely;

THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PEVELY, MISSOURI, AS FOLLOWS:

Section 1. Section 200.060 is hereby amended to read as follows:

Section 200.060 Composition of the Board. [R.O. 2004 §202.010; Ord. No. 1021 §1, 2-20-2003]



There is hereby established a Police Personnel Board, as follows:

The Police Personnel Board shall be composed of eight (8) members: one (1) of whom shall be a member of and selected by the Board of Aldermen of the City of Pevely and one (1) of whom shall be a member of the Pevely Police Department and recommended for the position by the Chief of Police, said person to carry the rank of sergeant or above. Both of these members shall be appointed for the term of one (1) year by the Mayor of the City with the consent of the majority of the elected members of the Board of Aldermen. The other four (4) members of the Police Personnel Board shall be appointed by the Mayor with the consent of the majority of the elected members of the Board of Aldermen, two (2) of which shall serve for a period of two (2) years and two (2) of which shall serve for a period of three (3) years. Two (2) alternate members may be appointed to serve in the absence of or disqualification of the regular members and shall serve for three (3) years. The Mayor, with the consent of a majority of the members of the Board of Aldermen, shall fill vacancies for any unexpired term. A member of the Police Personnel Board may be removed in the same manner as other appointed municipal officers pursuant to Section 79.240, RSMo. Members of the Police Personnel Board shall serve until their successors shall have been appointed and qualified. Members of the Board serve without pay for such service.

Please accept this memo as additional information regarding the proposed plans for the City Hall landscaping project. There are several documents attached hereto and I will explain them below.

Exhibit A – Cost Estimate for Landscaping and Storm Drain Repairs at City Hall

- As indicated by the title, this is the total cost estimate for this project.
- This estimate (\$5,500) includes City employees hauling the stone and doing the work.
- The top soil and washed creek stone would be purchased from Arnold Ready Mix.

Exhibit B – Rock Photo

- This is a photo of the washed creek stone we are planning to use in front of City Hall.
- The stone would be placed in the front of City Hall and would just barely wrap around the Police Department side. We will install grass seed and straw around the rest of the side and the back of the building.

Exhibit C – City Hall Aerial Map

- This map shows the approximate planned locations of the buried drain pipe coming from the downspouts at the back of the building.
- We are planning to run the water from the end of the downspouts to a "main" and then run the main to the north for it to deposit into the parking lot near the swale along the railroad's right-of-way.




