## Agenda

### [Street Repair Plan – City Administrator](#)

City Administrator Nathan Schauf presented the Board with the City's street repair plan for 2019 – 2023. A brief discussion took place over money being used for the repairs, getting quotes for someone work, which roads are in need for urgent repair, and working hours for the repairs.

### [Message Board – City Administrator](#)

City Administrator Nathan Schauf presented to the Board three quotes to repair the City Hall scrolling message board. A brief discussion took place over removing the sign or leaving it as is. It was decided to leave the message board as is.

### [Landscaping – Aldermen Markus](#)

Alderman Markus discussed the landscaping in front of City Hall. A brief discussion took place over getting pricing for rock, the downspouts being buried, and if our employees could do the landscaping.

### [Pay before buying fuel Ordinance Discussion - Aldermen Markus](#)

Alderman Markus discussed with the Board the ordinance Mobil would like to have in place in the City of Pevely. A brief discussion took place over each business being able to run their business as they see fit, the need for the ordinance, and how the ordinance affects the city.

### [Streets on Quail Meadow – Aldermen Coulson](#)

Alderman Coulson discussed painting the curbs in front of fire hydrants, changing the speed limit from 20 mph to 15 mph, and no parking on one side of the street. Aldermen Coulson also suggested that an Officer enforce the parking and handing our information letting citizens know about the changes in Hunters Glenn.

## Police Enforcement Strategies – Aldermen Coulson

Alderman Coulson discussed with the Board having a written enforcement plan for the Police Department and making sure they inform the Mayor and Board of Aldermen of any changes made to Policy before it is made. A brief discussion took place over the Police Department and waiting for the Chief position to be filled before any changes are made.

Alderman Menkhus asked City Attorney Sean Westhoff what is going on with the lease of the Park. A brief discussion took place over the lease agreement with the School.


Alderman Menkhus discussed the need for water retention basins after the rain last week. A brief discussion took place over the engineering and RFQ's for that work.

Alderman Menkhus discussed grass cutting by the City employees and grass clippings being left on the roads. A brief discussion took place over cleaning up the grass after mowing.

Alderman Tucker discussed cleaning the off ramps with the Board. A brief discussion took place over how to get the ramps cleaned up, and the liability along with cleaning them up ourselves.


Alderman Markus discussed subdivisions painting fire hydrants, the Sherriff's Office storage, and a dispensary in Pevely.
