AN ORDINANCE REPEALING THE WATER RATE SCHEDULE SET OUT IN SECTION 705.110 OF THE PEVELY MUNICIPAL CODE AND ADOPTING A REVISED WATER RATE SCHEDULE IN LIEU THEREOF, AND THE REVISED RATE SCHEDULE TO BECOME EFFECTIVE FOR THE JUNE 11, 2022, BILLING PERIOD

Be it ordained by the Board of Aldermen of the City of Pevely; State of Missouri as follows:

<u>Section 1</u>: The Water Rate Schedule in Section 705.110 shall be repealed effective starting the June 11, 2022, billing period

<u>Section 2</u>: The following water rate schedule is hereby adopted effective starting with the June billing period in 2022:

The rate for water service to customers of the waterworks system shall be as follows:

1. The monthly minimum bill shall include the first 2,000 gallons or less of water and will be based upon water meter size and customer type as follows:

a. Residential service: fifteen dollars and eighty-seven cents (\$15.87).

b. Commercial, industrial and all other user classes:

- 2. For all volume used in excess of two thousand (2,000) gallons per month, the unit charge shall be three dollars and ninety-eight cents (\$3.98) per one thousand (1,000) gallons.
- 3. Water usage will be billed per one thousand (1,000) gallons.

Section 3: Any previously enacted ordinances of the City of Pevely in conflict with the terms and conditions hereof are repealed in its entirety, and the terms hereof shall be controlling.

Section 4: This ordinance shall be in force and effect from and after its passage and approval as provided by law
