#### Impact Detail:

 The Jefferson County Tourism Commission is a newly formed organization to impact tourism in Jefferson County

 The Goal of the JCTC will be to organize and promote tourism in Jefferson County.

Increased tourism will bring more

- State and Federal funding is available for Organized Tourism commissions. We believe that an organized county tourism commission will be able to leverage more funding in Jefferson County and thus allow for increased marketing and event creation in the community.
- The Bottleneck Bridge ride has brought in more than \$100,000 in taxable revenue in the 5 years that it has existed. This includes restaurant usage, hotels and sales. This only includes the single day event and does not include the later impact of repeated tourism from initial draw. The JCTC will be able to organize and increase the impact of events like the Bottleneck Bridge Ride and help to organize new events into the county.
- The JCTC when running fully should be able to generate more than \$1,000,000 in taxable revenue to the county within the first 5 years of operation.
- Through collaboration with all the Tourism commissions and event coordinators of activities in the Jefferson county area the JCTC can expand and grow the presence and draw of tourism in Jefferson County.

### **COST**

The Cost will be part of a coalition of Tourism Commissions in Jefferson County and the Jefferson County Growth Association. The combined funding of the Festus Tourism Commission, Arnold Tourism Commission, and Pevely Tourism Commission along with the help of the Jefferson County Growth association will create the seed administration funding that will allow for the initial stages of securing a much larger sourcing of funds for Jefferson County Tourism.
